Subject: Earthquake of 06.Apr.2009. Request of help.

L'ASM spa (Aquilana Society Multiservices, www.asmaq.it) is a public company owned by the Municipality of L'Aquila (100.00% public capital), which provides waste management services throughout the vast territory municipal of 452 kmq.

The service has been conducted by the Municipality Company since 1969. From 1/1/2003 the Company is Spa (Limited company), which has legal personality and autonomy of enterprise and its status: Shares are owned by the city of L'Aquila (www.comune.laquila.it).

On 27 November 2008 the ASM SpA has signed with the Municipality of L'Aquila the service contract, which governs the management of municipal waste treatment and environmental hygiene.

After the earthquake of 06 April 2009 the Company immediately was reorganized in order to provide the service of waste management and environmental situation, in coordination with the Civil Defense, Department of ASL and prevention with all the facilities that are ready to be applied throughout Italy to support the city in this emergency.

In these days the company has organized to provide the following services throughout L'Aquila territory and also for all neighbourhood municipalities affected by the earthquake:

- services of non-hazardous waste collected in a different and non-different ones;
- hazardous waste service;
- Service and bulky WEEE (waste electrical and electronic equipment)
- used clothing collection service;
- Service road sweeping;
- Service liberation of embasures;
- illegal reclamation service;
- inert removal service;
- disinfecting service;
- rodent and insect disinfestations service

Considering the numerous certificates of solidarity made by companies and operators, including international, operating in the waste sector, which have offered to provide support to our Company to ensure the territory affected by the earthquake the services listed above, we activated a bank account to acquire donations from anyone wishing to offer an economical contribution, aimed at reconstruction of the services provided by our Company:
